# PONTIFICAL CATHOLIC UNIVERSITY OF CAMPINAS PD SELECTION PROCESS - PUCC-FAPESP NOTICE

# RESEARCH PLAN: PERSPECTIVES FOR PREDICTIVE POLICING PUBLIC POLICIES: BETWEEN THE EFFICIENCY OF PUBLIC SECURITY POLICIES AND THE PROTECTION OF INTERNATIONAL HUMAN RIGHTS STANDARDS

Considering Law No. 16.318, of November 25, 2022, which establishes the Municipal Program for the Prevention of Violent Attacks in Municipal Schools, as well as Decree No. 22.759, of April 27, 2023, which regulates Law No. 16.318, of November 25, 2022, the Pontifical Catholic University of Campinas hereby announces that it is holding an internal selection process to select a post-doctoral fellow (PD) to work on the **Égide Project: Violence, education and surveillance in schools in the municipality of Campinas**, which is funded by FAPESP (Process No. 2023/10005-1) and addresses the set of municipal public policies for preventing violence in school spaces. This research project is being carried out at the Pontifical Catholic University of Campinas), under the responsibility/coordination of Professor Lucas Catib de Laurentiis, with the support of the Public Safety and Education Departments of the Municipality of Campinas-SP. The program is part of the context of the proliferation of violent actions in public schools, especially attacks resulting in death, both in Brazil and around the world.

#### **1. PRELIMINARY PROVISIONS**

1.1 The selection process will be carried out under the responsibility of the members of the Research Project (Projeto Égide: Violência, educação e vigilância em Escolas do Município de Campinas), in compliance with the rules of the Public Notice, whose attributions will end with the publication of the act approving the final result of the selection process.

- The publicizing of the selection process will be supported by the Education and Public Security Departments of the Municipality of Campinas.
- 2. The selection process is intended to select researchers for the DP for the Égide Project: Violence, education and surveillance in schools in the municipality of Campinas, more specifically for doctors who have defended their doctorate in the area of law or related areas and have the following requirements:
  - Have completed their doctorate less than 7 years ago (or expect to complete it before the start of the scholarship period);
  - Have an excellent academic record, proven, among other things, by high-impact publications, research stays abroad, publications in conference proceedings and scientific initiation research;
  - Write a preliminary project related to the theme of the call for proposals;
  - Full dedication to the project (if the candidate has an employment contract, he/she must provide proof of absence work);
  - Reside in the metropolitan region of Campinas from the start of the scholarship period. Exceptionally, candidates who live in another municipality will be admitted, provided that they sign a commitment to participate in all the activities necessary for the full realization of the Project.
  - As a foreigner, it is the candidate's responsibility to check and provide all the necessary documentation for entry and stay in Brazil, in case of approval.
- 3. According to the work plan approved by FAPESP, the project has the following objectives: "Based on the study of these international experiences, this research aims to situate the public policy to be carried out at Égide under the gaze of international human rights protection law, while considering the pressing need to combat and prevent events against the life and physical integrity of teachers, students and school staff). Adopting bibliographic analysis as its methodology (academic papers published in the last 20 years will be collected from international databases), as well as documentary analysis (judgments of the Federal

Supreme Court will be collected, as well as systematizing Brazilian norms and international agreements internalized in the Brazilian legal system that deal with *predictive policing*), the project seeks to compose a robust theoretical framework regarding the concepts involved in predictive policing mechanisms, as well as mapping the dangers and consequences of the unrestricted application of these instruments. As an expected result, the research seeks to present a sophisticated theoretical framework, which presents concrete solutions to the criminological dilemmas verified in the Égide project".

- 4. The preliminary project to be presented by the candidate must clearly develop the theme indicated in the previous item in up to eight pages, based on an international theoretical framework, containing *i*) introduction; *ii*) development; *iii*) timetable with the expected submission of at least four scientific articles in high-impact journals; and *iv*) bibliographical references (maximum of 10 pages).
- 5. It is up to the members of the Research Project to select the **PD** fellows.
- The scholarship holder must take part in all the action fronts of the Égide Project: Violence, education and surveillance in schools in the municipality of Campinas.

### 2. THE POSITION

2.1. The position for this selection process, and in accordance with FAPESP process <u>2023/10005-1</u>, is shown in the table below:

- 2.2. The selected candidate may or may not express acceptance for the intended purpose.
  - 2.2.1.The selected candidate who expresses acceptance must comply with the work plan that is part of the Égide Project.
  - 2.2.2.The time and place of the proposed activity will be defined in face-toface or virtual mode, depending on the nature of the activity.

# 3. DUTIES AND SPECIFIC OBJECTIVES OF THE SCHOLARSHIP HOLDER

- 3.1. The specific duties of the scholarship holder are:
  - 3.1.1.Map international standards and Brazilian judgments (handed down by the Supreme Court) that deal with concepts and techniques related to predictive policing
  - 3.1.2.Identify, based on bibliographic research to be carried out in databases with recognized scientific impact (Scielo, Web of Science, Scopus), the predictive policing models implemented around the world, analyzing their effectiveness in promoting public safety.
  - 3.1.3.To present possible theoretical and technical solutions for mitigating the effects of the application of predictive policing in public schools (the object of the public policy carried out within the scope of Égide), without disregarding the need to preserve the safety of those who work in education.

#### 4. REGISTRATION

- 4.1. The candidate's registration will imply knowledge and acceptance of the rules and conditions set out in this Notice, in relation to which he/she cannot claim ignorance.
